- 4. To conduct sanctioned and licensed specialty shows and performance events abiding by the rules of the AKC.
- 5. To provide the opportunity for members to participate in competitive, social and educational events promoting bulldog breed health.

RELEASE OF LIABILITY

By signing and submitting this application for membership consideration, the applicant authorizes and agrees to hold harmless and without liability BCSDC, its officers and its members to investigate, solicit, obtain, and discuss any and all information pertaining to an applicant's moral and ethical character as it relates to the standards and guidelines set by BCSDC, its officers and members to have a bearing upon applicant's moral and ethical character. Applicant acknowledges that all information gathered shall be open for review and discussion among BCSDC's officers and members as part of the membership application process.

CODE OF ETHICS

- Members of BCSDC have an obligation to protect the welfare and the best interest of the bulldog breed by conducting themselves in a manner as to reflect credit on themselves, the bulldog breed and the club.
- Members who choose to exhibit or compete in conformation or performance events are expected to
 observe the highest standards of sportsmanship and will present themselves in such a manner as to
 reflect positively on the sport, the bulldog breed and the club they represent.
- Members shall exhibit good will at all events competitive, educational and social.
- Members who contemplate breeding, or who allow use of their stud dog for that purpose, shall adhere to the breed standard presented by the BCA.
- Members agree to abide by the BCA Code of Ethics.
- Members shall not engage in false or misleading advertising or misrepresentation of the bulldog breed, nor shall they malign their competition by making false or misleading statements regarding their competitor's dogs, breeding practices or person.

BLATANT DISREGARD FOR THE STANDARDS SET FORTH ABOVE SHALL BE CONSIDERED UNACCEPTABLE BEHAVIOR AND NOT SUPPORTED BY BCSDC.
